

RELEASE AND WAIVER OF LIABILITY

The Release and Waiver of Liability (the "Release") is executed by myself ("Participant") in favor of **Worthwhile**, a 501(c)(3) nonprofit corporation organized and existing under the laws of the Commonwealth of Pennsylvania, and each of its directors, officers, employees, agents, volunteers, event staff, and affiliated guests (collectively, the "Nonprofit").

The Participant desires to engage in awareness, fundraising, and related activities in connection with **Act Challenge events**, including but not limited to kickoff events and related programming.

I, the Participant, understand that the scope of my relationship with Worthwhile is limited to participation in Act Challenge events and related activities; that no compensation is expected in return for my participation; that Worthwhile will not provide any benefits traditionally associated with employment; and that I am responsible for my own insurance coverage in the event of personal injury or illness resulting from my participation.

1. Waiver and Release

I, the Participant, release and forever discharge and hold harmless the Nonprofit and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from my participation in Act Challenge events or related activities. I understand and acknowledge that this Release discharges the Nonprofit from any liability or claim that I may have with respect to bodily injury, personal injury, illness, death, or property damage that may result from or occur during my participation.

2. Insurance

I understand that Worthwhile does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical, health, or disability benefits or insurance of any nature in the event of injury, illness, death, or property damage. I expressly waive any such claim for compensation or liability on the part of Worthwhile.

3. Medical Treatment

I hereby release and forever discharge Worthwhile from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my participation in Act Challenge events or related activities.

4. Assumption of Risk

I understand that participation in Act Challenge events and related activities may involve activities that are physically demanding or otherwise hazardous. I expressly assume all risks of injury, illness, death, or property damage arising from my participation and release Worthwhile from all liability related thereto.

5. Confidentiality Policy

I agree that any confidential or proprietary information related to Worthwhile and its affiliated programs, including but not limited to participant information, program locations, treatment or educational records, and internal operations, shall be considered private and privileged and will not be disclosed to any person or entity without direct authorization from Worthwhile's Executive Director or Director of Operations. This obligation shall continue after the conclusion of my participation. Worthwhile shall be entitled to injunctive relief to prevent unauthorized disclosure.

6. Media Release

I grant Worthwhile permission to use any photographs, videos, or recordings taken of me during Act Challenge events, as well as any photos, videos, or other media that I submit or share in connection with my participation. I authorize Worthwhile to use such media for promotional, marketing, fundraising, educational, or other lawful purposes without compensation to me.

7. Other

I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the Commonwealth of Pennsylvania and shall be governed by and interpreted in accordance with those laws. If any provision of this Release is held to be invalid, the remaining provisions shall remain in full force and effect.
